 - Council reinstated section 6.1 as originally presented to say "Members shall accurately and adequately communicate the decisions of Council and Local Boards such that respect for the decision and decision making process is fostered.
 - Motions were defeated to exclude/remove sections 6.2 and 6.3 from the code.
 - section 6.4, as presented, will remain in the Code of Conduct.
- o The amended code of conduct will be brought back to the November 19th, 2024 meeting.
- o Community Safety Zone Stewartville Road (McNab Public School)
 - a request is to be sent the County of Renfrew to enact a By-Law that designates the portion of Stewartville Road in front of McNab Public School as a Community Safety Zone
- Alternative Voting & Vote Counting Equipment for the 2026 Municipal
 - Council approved the use of internet and telephone voting for the 2026 Municipal Election; A by-law will be brought forward to the November 19th, 2024 Meeting
- The Municipal Office will be closed on December 5th from 9:30 am to 1:00 to permit staff training.
- Village of White Lake Community Association Community Safety Zones
 - Staff was directed to draft a policy outlining the process for receiving requests and designating a Community Safety Zone. Council will forward any suggestions and required criteria they'd like to see in this policy.
- o OPP Detachment Board Budget 2025
 - Council received and supported the Budget information as submitted and confirmed the Townships responsibility under the Act to pay an equal share of the amount set out in the board's estimates.
- Recreation Activity Report September & October 2024
 - Burnstown Beach the Paddle Shack and Canteen are closed; Swim lines are removed.
 - Dochart Park AMBUSC season wrapped up at the end of September.
 - MCP Wooden Pole was replaced, and the halogen lights were reconnected at a cost of \$8,496.97.

- White Lake Park 4th time as a target of vandalism. Additional lighting and cameras to be installed.
- Men's Shed grand opening was supported by the township with picnic tables and barriers.
- John A. Gillies Recreation Centre (JAG) Court lines for two pickleball courts and road hockey were completed. Digital Entry System, Safety Netting at ball diamond, rink timer and replacement of light pole in front of the playground are works in progress.
- Waba Cottage Museum new windows were installed on the main floor. The Museum is now closed for the season.
- Docks have been removed for the season.
- Ball diamonds have all been dragged and preparations for the spring are under way.
- Recreation Master Plan Working with Zen City regarding the reporting analysis bug.
