Lori Hoddinott asked the Committee what is meant by the levels such as PWQO when referenced in the Arnprior Waste Disposal Site Report. The Director of Public Works

advised that PWQO (Provincial Water Quality Objectives) are a set of parameters or concentration levels for different indicators such as (unionized ammonia, dissolved oxygen, total phosphorus, boron, etc.) that would provide guidance as to if the water has been impacted by landfill leachate and if action would need to be taken to address the water quality.

Committee Member Fraser Campbell questioned if Council is interested in having Committee's if every request of staff has to go through a resolution to Council. With this, Committees have no ability to seek addition information from staff before making a decision.

Committee Chair Rosien reiterated that it is policy that Committee's cannot direct staff and that direction of staff can only come through Council to the CAO which will allocate staff resources. Committee Chair Rosien reinterested the importance of the Committee and the input from Committees has been a benefit in decisions that have been made.
