4.1 Paul Wideman - Concerns at Property on Lorlei Drive

Mr. Wideman (Property owner 140 Lorlei Drive) advised the committee of his concerns with where the snow is currently being plowed at the end of Lorlei Drive. Mr. Wideman is concerned that 50-70% of the snow/sand/salt is deposited on his property. Mr. Wideman's suggestion is that the snow should be pushed straight ahead past his property. Mr. Wideman indicated to the committee that vehicles and school buses turn ok at this location.

The Director of Public Works advised the committee that typically a one-way plow dead-ends to the right based on the fix angle of the plow. Pushing the snow to the left or to the centre will likely lead to a significant amount of snow build up in the entrances of 140

and 142 Lorlei Drive. The Director also advised that any extension of the road would need to be constructed to support vehicle traffic as the checkered board sign currently signifying the end of the road would also have to be relocated to beyond where any snow is stockpiled.
